Combined School: Fee Agreement and Consent Pack

Part 1: Parent / Guardian Agreement of Tuition for 2017

1. I agree that all the information above is correct and that the school will be informed of any changes that may occur.
2. One calendar month's notice will be given of any increases in education cost. Parents/guardians will be informed at any scheduled parents meetings and through newsletters.
3. One calendar months' notice will be given to the school prior to a learner leaving the school. If notice is not given, the person responsible for payment of the education costs will be liable for the outstanding amount from the time of notice having been given.
4. In signing the agreement, I agree to pay the cost in advance by the first day of the month. I understand that if the costs are not paid by the 1st day of the month, the learner will be removed from school until such time as the costs are paid. I agree to deposit the cost directly into the bank account of the school. The school, in turn, agrees to give the learner a letter informing the parent/guardian of such action prior to it occurring. The annual tuition fee for 2017 is R 17 750, 00 payable monthly over ten months – 1st January to the 1st October at R 1775 per month.
5. If the contract is breach by any party, I agree to continue making regular payments until such time as the dispute is settle. I also agree that should I institute legal action; matters/disputes will be handled through mediation, then arbitration before legal steps be taken. Should the school institute legal action, I agree to pay the legal cost.
6. After the disciplinary matters regarding the education and training of the learner, including suspension and expulsion from the school, the decision rests with the principal of the school or person authorized by the principal in consultation with the trust and the parents committee.
7. I hereby waive all claims that I may have against the school arising from injury, accident or any other cause involving the learner or myself, and hereby indemnity the school against such claims.
8. I hereby authorize the school to take all the steps at the principal's discretion which may be deemed necessary to have the learner admitted to a hospital and treated by a hospital or a doctor, or other medical attention, at my expense.
9. I further authorize the school to take a learner to events, venues outside the school grounds, and I indemnity the school against any claims arising from injury, accident or other cause involving the learner whilst the learner is attending such event.
10. This agreement shall begin on the date of signing this document and will remain in force for the duration of the learners stay at any Sparrow School.
11. The parent(s)/ guardian(s) must:
 - 11.1. Abide by the rules and regulations of the school and any changes to them by the school.

- 11.2. Have the learner immunized and submit proof of such immunization.
- 11.3. Mark all the clothes and possessions of the learner clearly and permanently with the learners' name.
- 11.4. Ensure that the learner is supplied with the proper and complete uniform of the school. I acknowledge that if the learner is found not wearing proper uniform, whatever he/she is wearing will be confiscated and the learner will have to pay **R100** to get it back, regardless of the colour of the item.
- 11.5. Attend all interview/s and the meetings called by the principal or educator to discuss the progress or behavior of the learner.
- 11.6. Notify the principal through the school secretary by letter, telephone, and fax or personally of any absence of the learner, and to provide reasons for such absences.
- 11.7. Undertake to ensure that the learner attends school regularly and arrives on time.

Part 2: Parent / Guardian Consent

In order to ensure the continued safety and security of learners as well as ensuring a healthy learning environment, Sparrow Schools provide for participation in the following:

2.1. Parent Communication

2.2. Random Drug Testing (until further notice is done at SANCA only)

Sparrow is a drug free zone and has an anti – drug zone tolerance policy in place, I agree to my child being tested when requested from the school if any suspicion occurs. I also accept that if the test is positive, the school has the right to insist that the learner attends a rehabilitation programme at the parent’s/ guardian’s expense. I agree to pay the testing fee and rehabilitation fee should my child/ward be randomly selected for a drug test and found positive.

2.3. Counseling / Therapy
